

Official Rules - XRT Xtreme Xperience Sweepstakes (the “Sweepstakes”)

NO PURCHASE OF ANY KIND IS NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED, TAXED OR RESTRICTED BY APPLICABLE LAW.

A. SPONSOR; CONTEST DATES

The Sweepstakes are sponsored and produced by Club Car, Inc. (“Club Car”). Promotion #1 begins at 9:00:01 a.m. PDT on 1/1/2008 and ends at 5:00:00 p.m. PDT on 4/30/08. Promotion #2 begins at 9:00:01 a.m. PDT on 6/1/08 and ends at 5:00:00 p.m. PDT on 9/30/08. Promotion #3 begins at 9:00:01 a.m. PDT on 10/1/08 and ends at 5:00:00 p.m. PDT on 12/31/08. All entries must be received by the contest deadlines listed above to be eligible for consideration.

B. ELIGIBILITY

This contest is open to all legal residents of the 50 United States (and the District of Columbia) and Canada who are twenty-one (21) years or older at the time of entry, except as otherwise indicated herein. You may not participate if the Sweepstakes (and will not be considered for the prizes) if you do not meet the eligibility requirements specified in these Official Rules (the “Rules”). Entrants must be present in the United States or Canada at the time they enter the Sweepstakes. If participants email or other address changes before the end of the contest, do NOT re-submit the entry using the new address, but rather, write via U.S. mail to the address below to submit the required change-of-address form. E. SELECTION OF WINNERS

To the maximum extent permitted by law, Participant acknowledges and agrees that no action or proceeding may be brought or maintained by Seller against Club Car except either in Georgia State Superior Court for Columbia County, or in the U.S. District Court for the Southern District of Georgia, Augusta Division.
